Owner hereby engages Manager to manage on behalf of Owner in accordance with the following:

1. Manager shall provide Owner with the planning, budgeting, scheduling, expediting, coordinating and supervising necessary for the timely execution of the Project by all workmen, suppliers of material, contractors, subcontractors and others (collectively, "Contractors") supplying materials or services to the Project.
2. Owner and Manager have discussed and agreed upon Project design and specifications, the details of which are set forth in Schedule "A" attached.
3. Owner and Manager have discussed and agreed upon the Project cost estimate as set forth in Schedule "B" attached. Manager has used its best effort to obtain and verify such estimate but does not warrant that the actual Project costs shall be as stated in Schedule "B".
4. Manager shall take all reasonable steps on behalf of Owner whereby the project shall be completed in a good and workmanlike manner in accordance with the design and specifications and cost estimate, subject to any changes.

5. The detail of services to be provided by Manager for Owner are as set forth in Schedule "C" attached.
6. In performing its duties under this Agreement, Manager shall be the limited agent of Owner for the purpose of obtaining, reviewing and discussing with Owner all quotes and bids by Contractors. Contracts, purchase orders and similar documents for the Project shall be in the name of Owner and may be signed by Manager on behalf of Owner provided they are consistent with this Agreement.
7. Nothing in this Agreement shall prevent or restrict Manager from acting as a Contractor for the purpose of performing work or service to the Project, provided such shall be fully disclosed to Owner.
8. Owner hereby indemnifies and holds harmless Manager from all debts, claims and liabilities incurred by Manager in the performance of its functions under this Agreement, provided that such functions are carried out by Manager within the scope of its authority
